This puppy is being sold with limited A.K.C. registration and spay/ neuter agreement as outlined below.

I/we ----- as the purchaser of the above described pup, agree to the following

Conditions set forth by the seller (Orino) and agree to abide by these conditions.

- 1.This dog or pup will not be chained or tied out as a usual method of control or restraint, nor will it be left exposed to inclement weather or conditions unattended.
- 2.Purchaser agrees that any time it is found that the dog or pup cannot be kept by them , purchaser agrees to return ownership of the pup or dog to breeder (Orino) with no reimbursement to the purchaser. Dog or pup cannot be given away or sold.
- 3.Limited registration means that no offspring of this dog or pup can be registered with A.K.C.
- 4.The purchaser agrees to spay or neuter this dog or pup prior to one year of age (consult your vet as to the appropriate age for your individual dog or pup).
- 5.Purchaser agrees that in registering your dog or pup that the prefix “LAKSDS” will precede the name of your choice.
- 6.If this dog or pup is ever found to be abused or neglected , seller has the right to take back ownership of the dog or pup with no reimbursement to the purchaser. Abuse or neglect to be verified by a licensed veterinarian before any action is taken.

Health Guarantee:

We recommend that you bring dog or pup to your vet within 5 days for a wellness check.

The seller guarantees this dog or pup to be free of debilitating genetic conditions for one year from birth, including but not limited to hip dysplasia, serious heart defects or kidney failure. In the event of the emergence of any of these conditions the seller agrees to replace this dog or pup with another of equivalent value or refund the purchase price, at sellers discretion, if the following conditions have been met:

- 1.The condition is diagnosed before one year of age.
- 2.The diagnosis is verified by two veterinarians, one of which will be paid for by the seller.
- 3.All other medical expenses to be paid by purchaser
- 4.In no event will the seller be liable for more than the purchase price of dog or pup.
